Cell phones, iPods, etc. are not allowed at Wendigo. They can greatly detract from the wilderness experience. Camp is an opportunity for your son to have a break from all the technology that is ever-present in his life throughout the rest of the year. As a child's dependence on electronic entertainment and communication increases, so does the importance of time away from it. Camp is an opportunity for your son to grow and experience greater independence and autonomy. He will form friendships with other boys that will last a lifetime. Keeping the camp environment free of distracting electronic devices will help this special bonding experience. A child who brings electronics to camp can unwittingly ruin the wilderness experience for his fellow campers. Thank you for your understanding and support of this policy.

- I acknowledge that Camp takes place in Ontario and that Ontario courts shall have jurisdiction over any claim, legal dispute or cause of action arising out of Camp, alleged breach of contract, or alleged negligence or other claim that leads to a legal proceeding against Camp or any of its agents. I hereby agree that if I commence any such legal proceedings they will be held only in Ontario and I hereby irrevocably submit to the exclusive jurisdiction of the Ontario Courts.
